“HUMAN RIGHTS AND HIV/AIDS: NOW MORE THAN EVER”

GLOBAL VILLAGE HOSTS HUMAN RIGHTS ACTIVISTS, HOT TOPICS

First rally on HIV and human rights on Thursday, August 7

From Monday, August 4 to Thursday, August 7, the **Human Rights Networking Zone in the AIDS 2008 Global Village** (Networking Zone #421) will host a series of events — discussion sessions, petitions, presentations, skills-building workshops, video training and screening — highlighting why attention to human rights is so critical in the response to HIV and AIDS. This is the first-ever networking zone focussed on human rights issues at an International AIDS Conference.

HOT TOPIC SESSIONS

During the four days of the conference, a series of **Hot Topic Sessions** will highlight important topical issues for human rights activists and policy-makers. Subjects to be addressed include:

- Criminalization of HIV transmission
- Travel restrictions for people living with HIV
- HIV testing policy and practice: the place of human rights
- Women's rights: violence, family law, hate crimes and sexual and reproductive healthcare
- HIV, HCV and TB in prisons and pre-trial detention centres
- Decriminalizing sex work to prevent HIV and promote human rights
- Drug control policy: public health and the human rights of people who use drugs
- Homophobia, HIV and human rights in Latin America
- HIV and young people's human rights

MEET THE EXPERTS

At an evening reception each day (18h30 – 20h15), visitors to the Human Rights Networking Zone will hear a short summary of human rights highlights from the day and have an opportunity to meet with leaders in the field of HIV and human rights:

- Abigail Noko, the HIV/AIDS specialist for the **Office of the UN High Commissioner for Human Rights** in Geneva, will be present on Monday, August 4 to speak and answer questions.
- On Tuesday, August 5, Anand Grover, the incoming **UN Special Rapporteur on the Right to Health**, will outline how HIV will figure in his mandate.
- A documentary about HIV and discrimination against deaf people will be introduced by Ricardo Hernández Forcada of **Mexico's National Human Rights Commission** on Thursday, August 7.

HUMAN RIGHTS AWARD

On Wednesday, August 6, Human Rights Watch and the Canadian HIV/AIDS Legal Network will announce the winner of the **2008 International Award for Action on HIV/AIDS and Human Rights** at a press conference in the Media Centre (13h00 – 13h45). That evening, the daily reception in the Human Rights Networking Zone (18h30 – 20h15) will also feature the Award winner and a short documentary

RALLY FOR HUMAN RIGHTS

The first-ever **International Rally for Human Rights and HIV/AIDS** will take place on Thursday, August 7 at the Global Village Main Stage (13h30 – 14h30).

During the rally, a copy of the declaration ***HIV/AIDS and Human Rights: Now More Than Ever***, endorsed by more than 500 organizations worldwide, will be presented to high-level officials and advocates, including:

- **Peter Piot**, UNAIDS Executive Director
- **Michel Kazatchkine**, Executive Director of the Global Fund to Fight AIDS, Tuberculosis and Malaria;
- **Mary Robinson**, President of Realizing Rights: The Ethical Globalization Initiative and former UN High Commissioner for Human Rights, among others.
