Some 200 activists, policy-makers, researchers and lawyers come together By all accounts, the 1st Annual Symposium on HIV, Law and Human Rights was a phenomenal success, surpassing our expectations by the number of people in attendance, the media coverage and the high calibre of panel members. Highlights included the public lecture on "The Criminalization of HIV Transmission" by Justice Edwin Cameron from the Constitutional Court of South Africa. A number of experts and community activists shared their insights on various panels on topics such as criminalization of exposure to HIV, access to affordable treatment in developing countries, Canada's drug policy, and the access to needle and syringe programs by people who are incarcerated. "Canada's Access to Medicines Regime" (CAMR), the law intended to help developing countries procure lower-cost, generic medicines through the effective use of compulsory licensing.
